Sign our letter to the European Union calling for non-renewal of the glyphosate permit.

The approval to use the herbicide glyphosate in the EU runs out on 15 December this year. In October, EU countries failed to agree on the proposal by the European Commission to grant a new 10-year permit. The Netherlands abstained in this vote. The proposal is now being considered by the Appeal Committee and a second vote will take place on 16 November. The European Food Safety Authority (EFSA) concludes that there are knowledge gaps and outstanding issues in the risk assessment for glyphosate. Scientists throughout Europe are raising their concern that the assessment dossier is selective in that publications by university-affiliated scientists are hardly included and that the assessment framework is seriously deficient to determine the effects on health and biodiversity, and ask for the precautionary principle to be applied:

- Scientists for Future NL and Scientist Rebellion have written a letter to the European Commission, the Appeal Committee and the Health and Safety commissioner, asking for a ban. We welcome scientists to co-sign our letter <u>here</u> until 8 November 13:00 CET.
- NGO Natuur & Milieu, together with professors Bas Bloem, Martina Vijver and Violette Geissen have written a letter to our government calling for the voices of concerned citizens and the insights from independent science to be heavily considered in the decision before us and to conduct additional research. Scientists can co-sign <u>this</u> <u>letter</u> too by 8 November.
- 3. The European Network of Scientists for Social and Environmental Responsibility (ENSSER) have called on the EU to respect the precautionary principle and withdraw glyphosate's authorization. Read their statement <u>here</u>.

Recap in-person national meeting 4 November

Saturday 4 November we had a national meeting in Utrecht. We shared the progress on our current projects, such as self censorship, sustainable banking and investments by our universities and research institutes, and S4F's social media strategy. We also discussed strategies we can use as S4F to be most effective on the national and the local level and how we can welcome and onboard new members, and brainstormed about potential new projects such as how we can join the international action demanding Elsevier to cut its extensive ties with



the fossil industry. Also coming are plans around climate ambassadors in faculties to speed up sustainability, having the warming stripes painted on university walls as a visible statement to the urgency of the crisis, and a call for research into peat extraction in The Netherlands. The next in-person meeting we will discuss energy transition delay tactics and how we can help make these visible.


