Twenty prominent economists comment on fossil fuel subsidies

Scientists4Future asked a group of prominent economist to reflect on fossil fuel subsidies (tax breaks). Twenty of them did so in the FD article "Fossiele subsidies ondermijnen het klimaatbeleid".

The title says it all: these subsidies are counterproductive and represent one of the most extreme inconsistencies in public policy ever. They can be compared to switching on airconditioning and heating at the same time, only cost money and yield nothing. Also, the often forwarded argument that ending fossil subsidies will cause companies to move to other

countries was flagged as incorrect. Large leakage effects, as in that industries relocate to other countries, have never been empirically demonstrated.

Update: responses to the open letter from S4F to NWO and KNAW

On Monday the 6th of November, an <u>S4F</u> <u>open letter</u> was sent to NWO and KNAW, calling for critical policies relating to collaboration between researchers and fossil energy companies. The letter had been signed by over 450 scientists, academics, and employees from 13 universities and 11 research institutes.

The letter was based on the opinion that the activities of the fossil energy sector continue to be in direct opposition to the conclusions of the international scientific community, such as those recorded in the <u>United</u> Nations IPCC reports. Indeed, some <u>universities</u> and <u>institutes</u> have already published clearer policies or fully ceased their collaboration with the fossil energy sector. The signatories of the letter call on NWO and KNAW to only allow and encourage new collaborations with companies from the fossil energy sector that can prove themselves committed in the short

writers, KNAW and our organization. Because solutions are never closer by writing open letters to each other or by completely closing doors to collaboration. The purpose of the conversation is to try to understand each other instead of judging each other. How can we jointly make a reliable contribution to the energy transition? What would be the role of companies in the fossil fuel industry? How do these companies and science come closer together and what alternatives are available if we can't reach an agreement together? What are the dilemmas surrounding this issue?"

In brief, Prof. Marileen Dogterom stated "We believe that the institutional level is the right place to establish [such] policies, after careful and balanced debate within the organization (...) In our role as the voice of science, we are happy to facilitate the debate on collaboration with the fossil industry and we hope to provide research institutions with tools for assessment frameworks (...) Academic freedom and scientific integrity also have the KNAW's constant attention. The discussion about this also includes themes that touch on collaboration with the fossil industry, such as: independence and undesirable influence by clients or third parties and the accountability of scientists as laid down in the code of conduct for scientific integrity."

term to the Paris climate agreement. The letter was covered in several <u>news outlets</u>.

On Friday 10th November, S4F received separately <u>a reply</u> from Prof. Marileen Dogterom, president of KNAW, and <u>a reply</u> from Prof. Marcel Levi, chairperson of the board of NWO. Both letters are also available to read on the S4F Slack workspace, in the channel <u>#proj-open-letternwo-knaw-fossil-fuel-collaborations</u>.

In brief, Prof. Marcel Levi stated that "The issue of climate change is too big and too complex to solve without each other (...) 
